COMPETITION NOTICE

The Giovanni Bottesini Musical Association is pleased to announce the 9th International Double Bass Competition "Giovanni Bottesini".

The competition will take place in **Crema from 21st to 27th October 2024**.

The competition is open to double bass players of all nationalities born between 28th of October 1988 and 21st October 2006.

Dominique Meyer, Superintendent and Artistic Director of the Teatro alla Scala in Milan, will join the Jury during the final of the Competition as an **Honorary Juror**.

The members of the Jury will formulate a set of internal guidelines in order to establish the criteria, which allow them to carry out their duties.

In the case of a tie, the Jury President's vote will count for two.

Any member of the Jury who is related to or who is/was the teacher of a competitor within the last two years is not allowed to vote for that competitor.

The Jury's decisions are final.

PRIZES

- **First Prize "Walter Stauffer"**:
a double bass made by Marco Nollí luthier - value € 30.000 (thirty thousand)
plus a bow case by Bogaro & Clemente*
- **Second Prize "Camera di Commercio di Cremona"**
a double bass made by Richard Gonon luthier - value € 20.000 (twenty thousand)
plus a bow case by Bogaro & Clemente*
- **Third Prize:**
€ 3.000 (three thousand) plus a bow case by Bogaro & Clemente*

- **Under 25 Award:**
€ 1.000 (one thousand)*
- **Marco Pasquino Prize:**
a double bass bow, offered by the bow makers Marco Pasquino
- Other prizes or concert prizes could be offered by the organization.

It is the Jury's right not to award the prizes.

* Cash prizes will be paid out by the organisation within 60 days of the competition finals by bank transfer.

REGISTRATION

Registration for the competition implies full acceptance of all the rules that govern its performance. Each candidate must send following documents to the competition secretariat, no later than **9th September 2024**:

1. the registration form completed in all its parts;
2. a photocopy of a document certifying the identity and nationality;
3. a recent photograph;
4. a short curriculum vitae (in Italian or in English);
5. the list of selected pieces from the musical program that the competitor has chosen;
6. a scan of the receipt of the payment of € 150.00 as the registration fee for the Competition.

Any costs of the transaction are at the expense of the competitors.

The payment of the fee will validate the registration and can be made by bank transfer to the bank account in the name of the Giovanni Bottesini Musical Association at Banco BPM - Crema headquarters.

COMPETITION PROGRAM

The competition will take place in Crema and Cremona from 21st to 27th October 2024 and it will be organized as followed:

- a) Secretariat opening (21 October)
- b) First Round (22,23 October)
- c) Second Round (24 October)
- d) Semi final (25 October)
- e) Rehearsals with the Orchestra Bottesini (26 October)
- f) Final with the Orchestra Bottesini (27 October)

The Organising Comitee reserves the right to start the first round on Monday 21 October 2024.

Each competitor will receive a convocation by 20 September 2024.

It is possible to express a date preference for the first round, justifying the request. For logistical reasons, the organisation cannot guarantee to be able to accommodate all requests.

Each competitor will be given the opportunity to rehearse the competition pieces before the audition with the official pianists provided by the organisation at the times communicated by the Secretariat at the official convocations.

It will not be possible to be accompanied by a pianist other than those provided by the Competition.

The organisation will provide rehearsal rooms, which are indicated at the time of the convocation.

A detailed program of the competition days will be communicated before 20 September 2024.

MUSIC PROGRAM

Preliminary regulation

- The musical instrument must have a string length of at least 100 cm.
- The candidates must play all their repertoire using solo tuning.
- The jury may decide to listen to the entire program, each piece or just an excerpt of the program or piece.
- For each piece recommended editions are requested (the suggested list of compositions and their related editions are listed below in alphabetical order), but performances based on original manuscripts are always allowed.
- No memory execution required

Data Controller and persons responsible for the processing of personal data

Purposes of data processing

The processing is aimed at the correct and complete execution of the relationship. Your data will be:

- processed in order to fulfill the obligations envisaged in the fiscal and accounting field;

- shared with the press that intend to publish information about the event;

Legal basis of the processing

Consequences of non-disclosure of personal data

Data retention
