GENERAL RULES FOR PARTICIPATION AT THE EVENT

1. ORGANISER

Associazione Musicale Giovanni Bottesini, via Vimercati 11, Crema.

2. LOCATION. DATE AND TIME OF THE EVENT - SET-UPS AND DISMANTLING

The event will take place on Sunday, 16th of October 2022, at the Sala Rossa of Palazzo Vescovile, Piazza del Duomo n° 27. At 5.30 pm there will be a concert for the final of the Bottesini Competition at Chiesa di San Bernardino, Auditorium Bruno Manenti, few meters from the Palazzo Vescovile.

The organisation only provides exhibitors with the exhibition space. The exhibitor is responsible for the design (support surface, chairs, positioning of the tools, etc.). For the loading/unloading of the material, it will be possible to have access to Piazza Duomo, coming from via Cesare Battisti, and to stop in front of the Palazzo Vescovile, but only for the time required by the loading and unloading.

- Set up times: From 9am to 10am.
- Opening hours to the public: from 10am to 5.30pm.
- Dismantling time: from 5.30pm to 7.30pm.

In order to allow free admission for Exhibitors and their staff, the Organizer will distribute passes in the quantities requested by the Exhibitor on the participation form. The Exhibitor is in any case responsible, to all intents and purposes, for the behaviour of those to whom he provides entry tickets, as well as for the behaviour of his own employees, auxiliaries and collaborators, in the performance of the tasks assigned to them.

3. WHO IS ELIGIBLE

Luthiers from all over the world can apply for the exhibition.

4. ADMISSION

The management of the Bottesini Competition reserves the authority to decide on admission and to reduce the number of instruments proposed due to the limits of the space.

5. APPLICATION FORM - REQUEST SPACES

The application form and space request must be completed in its entirety, signed and sent to the email: **segreteria@associazionebottesini.com** together with the privacy form for the processing of data and images.

The Application Form must be received by the **12th of October** and will result in your acceptance of these "General Rules for Participation". In case of cancellation after the deadline for registration, the exhibitor must pay a penalty of 50 euros by bank transfer to the current account in the name of the Associazione Musicale Giovanni Bottesini at the Banco BPM - headquarters of Crema. 6. ASSIGNMENT AND SELECTION OF LOCATION FOR EXHIBITION

Exhibitors are given the opportunity to choose their exhibition location on the basis of their arrival time. In any case, the Organiser will have the authority to move or reduce the exhibition space for particular logistical and organisational reasons.

7. THEFT SURVEILLANCE – RESPONSIBILITY FOR DAMAGES AND THEFTS – FREE FROM RESPONSIBILITY

During the opening hours of the exhibition spaces, the Exhibitor must supervise its own exhibition space directly or through its own personnel. The Exhibitor is obliged to supervise the exhibition space with its own personnel during the entire opening period of the exhibition. The Exhibitor is the sole custodian, for the entire period of the event (including the set-up/disassembly period), of all materials, goods and furnishings present in the stand. The Organizer does not assume any responsibility for goods, materials or anything else left unattended by the Exhibitors inside the exhibition area and in the external areas of the structure hosting the event. The Organizer is exonerated from any and all liability for theft and/or damage that may occur to the detriment of the Exhibitor. The Exhibitor shall be liable for any direct or indirect damage which for any reason is attributable to him or to any staff working on his behalf.

8. INSURANCE

The Organiser and the host structure are expressly exonerated from any responsibility for loss, theft of exhibits or damage that for any reason should occur in the assigned exhibition space, during the course of the event or during the preparation and dismantling of the exhibition spaces.

Purposes of data processing

The processing is aimed at the correct and complete execution of the relationship. Your data will be:

- processed in order to fulfill the obligations envisaged in the fiscal and accounting field;
- transmitted to collaborators, consultants or companies that may need to be involved in theperformance of the relationship;
- shared with the press that intend to publish information about the event;
- managed for the purpose of fulfilling the obligations incumbent on the Owner and provided for by the regulations in force.

Personal data may be included in both paper and electronic archives, including portable devices and processed in ways strictly necessary to meet the purposes indicated above.

Legal basis of the processing

Giovanni Bottesini Musical Association deals with personal data for the execution of the

relationship, of which you are a part. Further treatments will take place only as a consequence of this relationship, where it is necessary to fulfill a legal obligation incumbent on the Owner; that is based on the express consent.

Consequences of non-disclosure of personal data

Due to the requirement to comply with regulatory obligations, for example, the obligations





related

to the keeping of accounting records and tax, the disclosure of personal data is a requirement for thecommencement of the relationship itself.

Data retention

Your personal data, the subject of treatment for the above-mentioned purposes, will be kept for the

whole duration of the relationship and, subsequently, for the time in which the Owner is subject to conservation obligations for fiscal purposes or for other purposes foreseen by legal or regulatory provisions.

Data communication

Your personal data may be communicated to:

- 1. consultants and / or accountants and / or legal advisors who provide functional services for thepurposes indicated above;
- 2. persons who process the data, in execution of specific legal obligations;
- 3. judicial or administrative authorities, for the fulfillment of legal obligations.

Profiling and dissemination of data

The Owner performs profiling with respect to the data provided by you, in particular regarding the

geographical origin, age, type of performance. Personal data, however, are not the subject of automated decision-making processes. Your personal data are not subject to disclosure by any fullyautomated decision-making process.

Rights of the data subject

Among the rights granted to you by the GDPR and by the national legislation in force are those of:

- ask the Owner to access your personal data and information; the correction of inaccurate data or the integration of incomplete data; the cancellation of personal data concerning you (upon the occurrence of one of the conditions indicated in article 17, paragraph 1 of the GDPR and in compliance with the exceptions provided for in





paragraph 3 of the same article); the limitation of the processing of your personal data (upon the use of one of the hypotheses indicated in Article 18, paragraph 1 of the GDPR);

- request and obtain from the Owner in the cases in which the legal basis of the treatment is a contract or consent, and it is done by electronic means your personal data in a structured and readable format by electronic device, also in order to communicate such data to another data controller (the so-called right to the portability of personal data);
- oppose at any time the processing of your personal data in the occurrence of particular situations that affect you;
