# **COMPETITION NOTICE**

The Giovanni Bottesini Musical Association is pleased to announce the 8<sup>th</sup> International Double Bass Competition "Giovanni Bottesini". The competition is organized with the collaboration of Comune di Crema and Fondazione San Domenico and will take place in **Crema from 11<sup>th</sup> to 16<sup>th</sup> October 2022.** 

The competition is open to double bass players of all nationalities. Singers should be born between 17th of October 1986 and 10th October 2004.

The members of the Jury will formulate a set of internal guidelines in order to establish the criteria, which allow them to carry out their duties.

In the case of a tie, the Jury President's vote will count for two.

Any member of the Jury who is related to or who is/was the teacher of a competitor within the last two years is not allowed to vote for that competitor.

The Jury's decisions are final.

First Prize Walter Stauffer: a double bass made by the Italian violin maker Marco Nolli - value € 30.000

Second Prize "Camera di Commercio di Cremona":€ 5.000,00 \*

Third Prize "LGH Linea Group Holding": € 3.000,00 \*

**Scholarships:** all the participants who pass the first round will be entitled to a Scholarship of € 400,00 \*

Adriano Massari Prize: a double bass bow, offered by the bow makers Adriano Massari

**Marco Pasquino Prize:** a double bass bow, offered by the bow maker Marco Pasquino.

Other prizes or concert prizes could be offered by the organization.

It is the Jury's right not to award the prizes. Ex-aequo are allowed.

\* All cash prizes and scholarships will be paid within 60 days from the Competition Final by bank transfer. The scholarships will not be combined with the first three prizes.

## REGISTRATION

Registration for the competition implies full acceptance of all the rules that govern its performance. Each candidate must send to the competition secretariat, no later than the 5<sup>th</sup> **September 2022**, the following documents:

- 1. the registration form completed in all its parts;
- 2. a photocopy of a document certifying the identity and nationality;
- 3. a recent photograph;
- 4. a short curriculum vitae (in Italian or in English);
- 5. the list of selected pieces from the musical program that the competitor has chosen;
- 6. a scan of the receipt of the payment of € 130.00 as the registration fee for the

Competition. Any costs of the transaction are at the expense of the competitors.

The payment of the fee will validate the registration and can be made by bank transfer to the current account in the name of the Giovanni Bottesini Musical Association at Banco BPM - Crema headquarters.

The first 60 members will be automatically admitted to the competition. The artistic director reserves the right to admit additional candidates.

## **COMPETITION PROGRAM**

The competition will take place in Crema from the 11<sup>th</sup> to 16<sup>th</sup> October 2022 and it will be organized as followed:

- a. First Round (11,12 october)
- b. Second Round (13 october)
- c. Third Round (14 october)
- d. Final Round with the Orchestra di Padova e del Veneto (16 october)

Each competitor will receive a convocation by September 14th, 2022.

Prior to the audition, each competitor will be given the opportunity to rehearse the chosen pieces with the official pianists of the organization for a time equivalent to the duration of the audition.

It will not be possible to be accompanied by a pianist other than those provided by the Competition.

The organization will make available the rehearsal rooms, which will be accessible from the day before the start of the Competition.

An information point will be opened from the day before the start of the Competition.

A detailed program of the competition days will be communicated before 14th September 2022.

#### MUSICAL PROGRAM

## **Preliminary regulation**

- The musical instrument must have a string length of at least 102 cm.
- The candidates must play all their repertoire using solo tuning.

- The jury may decide to listen to the entire program, each piece or just an excerpt of the program or piece.
- For each piece recommended editions are requested (the suggested list of compositions and their related editions are listed below in alphabetical order), but performances based on autograph manuscripts are always allowed.
- No memory execution required
- For this specific edition dedicated to the bicentenary of Giovanni Bottesini, the entire musical program is based on the compositions of Giovanni Bottesini.

## DISCLOSURE PERSUANT TO ARTICLE 13 OF EUROPEAN REGULATION 2016/679

### Data Controller and persons responsible for the processing of personal data

## Purposes of data processing

The processing is aimed at the correct and complete execution of the relationship. Your data will be:

- processed in order to fulfill the obligations envisaged in the fiscal and accounting field;
- transmitted to collaborators, consultants or companies that may need to be involved in the performance of the relationship;
- shared with the press that intend to publish information about the event;
- managed for the purpose of fulfilling the obligations incumbent on the Owner and provided for by the regulations in force.

Personal data may be included in both paper and electronic archives, including portable devices and processed in ways strictly necessary to meet the purposes indicated above.

# Legal basis of the processing

Giovanni Bottesini Musical Association deals with personal data for the execution of the relationship, of which you are a part. # Consequences of non-disclosure of personal data

Due to the requirement to comply with regulatory obligations, for example, the obligations related to the keeping of accounting records and tax, the disclosure of personal data is a requirement for the commencement of the relationship itself.

## **Data retention**

- request and obtain from the Owner in the cases in which the legal basis of the treatment is a contract or consent, and it is done by electronic means your personal data in a structured and readable format by electronic device, also in order to communicate such data to another data controller (the so-called right to the portability of personal data);
